

CHRISTINE PINKHAM SUMMATION

Nathaniel A. Herrera son of Christine Pinkham

Date of birth November 23, 1997

Nathaniel & Family moved to San Diego, CA. March 2013

Nathaniel first day of school September 9, 2013

I noticed along with his night time licensed vocational nurse that Nathaniel was developing a pressure sore on his elbow and he was displaying new symptoms never before displayed of post-traumatic stress.

I visited the classroom on September 20, 2013 with my aunt and observed unsanitary conditions in the classroom, and spoke to Vice Principal REDACTED about the unsanitary conditions in the classroom, plus the lack of interaction between the classroom staff and the children along with my concerns for Nathaniel's physical and mental well being. My concerns were followed up by an email sent to Vice Principal REDACTED.

September 24, 2013 Nathaniel boarded the school bus at 0630 with his external feeding machine at the rate prescribed rate of 100mL per hour (the rate was recorded and charted on his medical chart). At 0744 I received a call stating that the machine was found at the rate of 400mL per hour.

On September 24, 2013 I arrived at the school to personally inquire what happened on the bus and I was met by the Vice Principal after she spoke to the staff and her response was "I don't know what happened while your son was in our custody and since he cannot speak he cannot tell us what happened to him"

I filed a Uniform complaint 1700 because Vice Principal REDACTED refused to follow Administrative Procedure no. 6370 specifically page 9 section 4 Reports of incidents involving staff members. As you are fully aware that in the administrative procedure states that a mandated reporter makes a report (verbal) as soon as practicably possible followed by a written report done 36 hours after the phone call is placed. Also in various locations of the administrative procedure 6370 it states that the mandated reporter job is to report and not to investigate, when in doubt, always report. Page 6

Vice Principal REDACTED made a report to child protective services on October 3, 2013 a full 6 business days after the incident of abuse. The report was made against the parent (myself) when REDACTED was made fully aware of Nathaniel's living conditions and amount of providers that provide medical services in and out of the home via email.

After I pulled my son from Mission Bay High School, the staff of Mission Bay High School engaged in a pattern of intimidation by threatening to charge me with truancy and calling child welfare services various times to make false allegations against REDACTED.

Nathaniel attended school twice in the month of October 2013 where the same The same aide that travels on the bus with Nathaniel works in the same class that Nathaniel is in proceeded to yank my son's pubic hair from the root and the second time we were there, she asphyxiated another student prompting the other aide to run the other room to get the suction machine and save the child from certain death.

I reported these incidents to the Vice Principal and the Principal REDACTED and no action was taken to secure the safety of the children. I have reported these incidents to REDACTED , REDACTED, REDACTED, and REDACTED and nothing has been done.

Please note that REDACTED was removed by police sometime in January 2013 due to mental distress, it prompted a 6 week leave of absence on the part of REDACTED. Principal REDACTED and Vice Principal REDACTED were fully aware that REDACTED was abuse towards children and yet the Principal REDACTED decided to put REDACTED in a class of medically fragile, non verbal children. These facts were known to Principal REDACTED as far back as 2013. The student in question is REDACTED who still attends Mission Bay High School. His mother's name is REDACTED her number is REDACTED.
